Nino Ricci's first novel was the internationally acclaimed *Lives of the Saints*, a *New York Times* Notable Book and winner in Canada of the Governor General's Award and in England of the Betty Trask Award and the Winifred Holtby Prize. Published in seventeen countries, it formed the first volume of a trilogy that continued with *In a Glass House*, hailed by the *Times* as a "genuine achievement," and *Where She Has Gone*, shortlisted for the Giller Prize and longlisted for the *Guardian* Fiction Award. The *Lives of the Saints* trilogy was adapted for a television miniseries starring Sophia Loren and Kris Kristofferson.

Ricci followed up his trilogy with *Testament*, a fictional retelling of the life of Jesus hailed as a "masterpiece" by *Saturday Night* and a *Booklist* Choice for the Top Ten Historical Novels of the Year as well as a *Times Literary Supplement* Book of the Year. His novel *The Origin of Species* earned him his second Governor General's Award for Fiction as well as the

Canadian Authors Fiction Award. His most recent novel, *Sleep*, was also the winner of the Canadian Authors Award and a *Globe and Mail*, *National Post* and *Toronto Star* Best Book. *Quill & Quire* hailed it as "Ricci's darkest and most thematically daring work to date. . . . A frightening and essential addition to the oeuvre of one of this country's best and most important writers."

Ricci is a past president of PEN Canada, a writers' human rights organization that works for freedom of expression and has taught literature and creative writing at institutions across North America, including the University of Toronto, Colorado College, and Princeton University. He is currently in residence as the Killam Visiting Professor in Canadian Studies at Bridgewater State University.



Bernadette Jordan (BA [Political Science], St. Francis Xavier University, 1984) was raised on the South Shore of Nova Scotia in a small fishing community. Her love of her community and desire to see it grow and

thrive started at a young age when she became a community volunteer while in junior high school.

In 2015, Bernadette ran for and won the federal riding of South Shore-St. Margarets by the largest margin ever in the riding and became the first woman to hold the seat. In her first years in government, she was the chair of the Atlantic Liberal Caucus, a member of the standing committees on the Status of Women and on the Scrutiny of Regulations, and the chair of the Standing Committee on Fisheries and Oceans. In 2019, she became the first minister of rural economic development. Later that same year she became minister of fisheries, oceans and the Canadian Coast Guard. This made Bernadette the first woman elected in Nova Scotia to hold a seat at the Cabinet table. After leaving politics in 2021, Bernadette went back to her fund development roots, accepting a position as the national director of philanthropy with Shelter Movers, a volunteer-powered charity providing free moving and storage services to people, primarily women and children, leaving abuse.



Brittany Luby is the author of four children's books, including *When the Stars Came Home*, *Mnoomin Maan'gowing/The Gift of Mnoomin*, *Mii mandaan ezhi-gkendmaanh/This Is How I Know, and Encounter*.

Luby is also the author of historical non-fiction for adult readers. Her book *Dammed* has been described as "thoughtful, deeply researched, and urgent" and inspires individuals to "think deeply about how a pathway to reconciliation needs to be bathed in... reciprocity."

Luby has won numerous awards for both her fiction and non-fiction writing, including the Ruth & Sylvia Schwartz Children's Picture Book Award (2022), Best Book in Canadian Environmental History (2022), and the Governor-General's History Award for Excellence in Scholarly Research (2021). She also received an Honorable Mention for the Labriola Center American Indian National Book Award in the United States.

In 2023, Luby was made a member of the Royal Society of Canada's College of New Scholars, Artists, and Scientists. She works as a professor of History at the University of Guelph.



Jane Mariotti is an ecologist dedicated to community-centered research and sustainable land-based food systems. Her prior work focused on Manomin, a culturally significant food plant within Treaty #3 territory in northern Ontario. Her master's research aims to deepen our understanding of northern soils' food-growing potential to bolster resilient and adaptive food systems in southern Northwest Territories. Additionally, her work will investigate the impact of wildfire on soil fertility, food-growing capacity, and nutrient loss.
